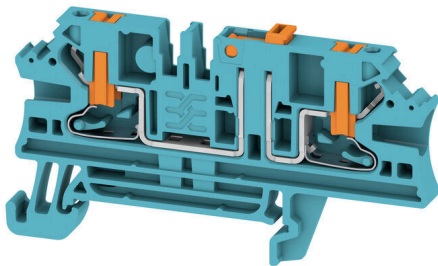

With test disconnect terminals you measure electric circuits in the absence of voltage. While the disconnecting points clearance and creepage distance is not assessed in dimensional terms, the specified rated impulse voltage strength must be proven.
